## •Launch of Horizon 2020 immediately after its adoption:

## A major achievement!

- Adoption of first Work Programme on 10 December 2013
  - √ 65 calls (12 focus areas) for 2014 embedding key features and novelties
  - ✓ Broader and fewer topics
  - ✓ Over € 15 billion funding over first two years (€ 9.3 billion in 2014)
  - ✓ First call deadlines as from March 2014
- In the first six months
  - More than 2.1 million visits on Participant Portal in December 2013
  - More than 16,000 proposals submitted
  - Nearly 5,300 expert evaluators contracted (60,000 experts registered)
- Participant Portal as single gateway for all participants
- New IT tools and streamlined business processes
